Sibling Discounts - Families with two or more children enrolled at SMM will be offered a 10% discount on the Tuition Fees for the 2nd and subsequent children with the following conditions:

1. Discount will apply to the lowest fees, but not applicable for Tiny Tots
2. Sibling discount does not apply for company payments

Development Fee * - Should the Tiny Tots subsequently enroll for Pre-Nursery the following year, an additional \$1000 + 7% GST development levy is payable.

Re-enrollment Fee ** - subject to changes.

This amount will be offset against the school fees in semester 1. Where confirmation of re-enrollment with payment is not received by the re-enrollment due date, SMM will regard this as notice of intention to withdraw the student from the school. Should that student then wish to return to SMM in the new academic year, the student will need to register again and pay the applicable registration fees, and the development levy in addition to the school fees and any other amounts payable.

All fees are quoted in Singapore dollars and include goods and services tax at the prevailing rate of 7%, where applicable. Fees are reviewed annually and subject to change.

Payment Terms

SMM accepts payment by cash, cheque, bank transfer and giro.

Students commencing classes after 1st November 2017 and 1st May 2018 are required to pay Tuition Fees for half semester.
