All School Fees are payable before the commencement of each semester. A 5% p.a. late payment interest will be charged on any fee payments that are not received by due date



Sibling Discounts - Families with two or more children enrolled at SMMIS will be offered a 10% discount on the Tuition Fees for the 2nd and subsequent children with the following conditions:

1. Discount will apply to the lowest fees, but not applicable for Tiny Tots
2. Sibling discount does not apply for company payments

Development Fee * - Should a Tiny Tots student subsequently enroll for Pre-Nursery the following year, a top up to the full development fee of \$1000 + 7% GST is payable.

Re-Enrolment Fee ** - subject to changes.

This amount will be offset against the school fees in semester 1. Where confirmation of re-enrolment with payment is not received by the re-enrolment due date, SMMIS will regard this as notice of intention to withdraw the student from the school. Should that student then wish to return to SMMIS in the new academic year, the student will need to register again and pay the applicable registration fees, and the development levy in addition to the school fees and any other amounts payable.

All fees are quoted in Singapore dollars and include goods and services tax at the prevailing rate of 7%, where applicable. Fees are reviewed annually and subject to change.

Payment Terms

SMMIS accepts payment by cheques, interbank or telegraphic transfer, Giro and cash.
